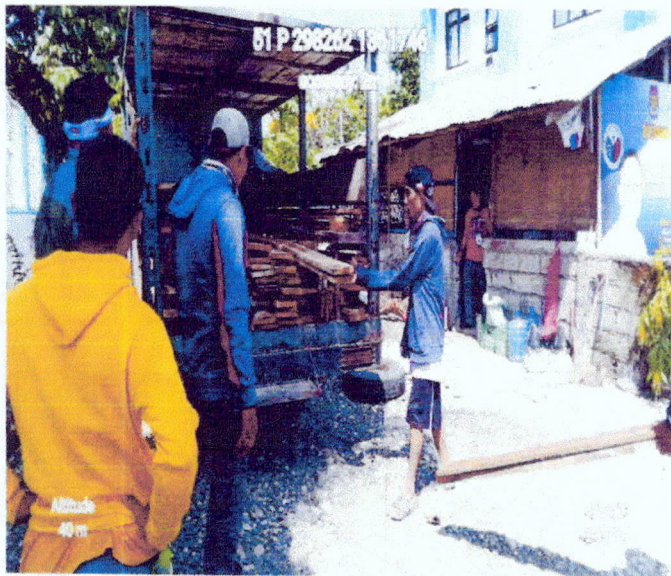
GEOTAG PHOTOS OF APPREHENDED LUMBER.



This pertains to the Violation of PD 705 known as Illegal Logging that transpired on April 18, 2023 at 11:45 AM at Torio Fishpond and Salt Farm located at Laste, Magsaysay, Occidental Mindoro wherein **the suspect was identified as Charlie Barrios Salimbay , 45 years old, male, married, fishpond and salt farm caretaker of Torio Fishpond and Salt Farm and resident of Brgy Laste, Magsaysay, Occidental Mindoro.**

3. On April 18, 2023 at 9:00 AM, personnel of CENRO, Jomar B Serquina, Deputy Chief EMS and Delfin N Casticimo, Forest Ranger coordinate with this station informing that they have information that illegal logging activities was transpired at Barangay Laste, Magsaysay, Occidental Mindoro. Upon briefing conducted by PCPT ARISTOTLE A CALAYAG, ACOP personnel from this station led by PEMS Alexander R Garcia were dispatched to assist the said operation.
