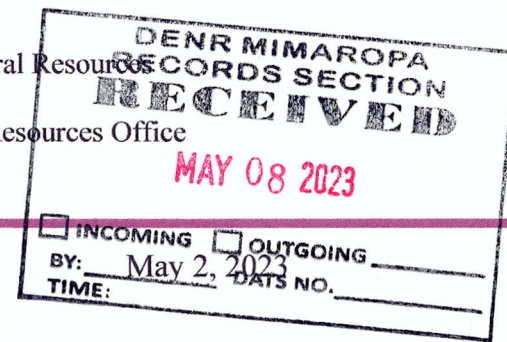

SUBJECT : **SUBMISSION REPORT ON THE CONDUCT OF DALAW-TURO ON MARCH 28, 2023**

The Dalaw-Turo program is one of the activities of the Department of Environment and Natural Resources (DENR) for its Information, Education, and Communication Campaign. It is conducted in partnership with the academe and the communities to heighten their awareness of DENR's programs and projects as well as to inform the participants of their roles in maintaining a clean and healthy environment.

Please be informed that this Office has conducted a Dalaw-Turo which focused on Biodiversity, Climate Change, R.A 9147 or an act providing for the conservation of wildlife resources and their habitats, appropriating funds therefore and other purposes, and R.A 9003 an act providing for an ecological solid waste management program, creating the necessary institutional mechanisms and incentives, declaring certain acts prohibited and providing penalties, appropriating funds therefor, and for other purposes. The activity was participated by the Students, Teachers, and nonteaching staff of San Mariano National High School in Barangay San Mariano, Roxas, Oriental Mindoro. A total of 215 females and 85 males participated in the activity.

The activity was opened by Mam Abegail Aballos, Teacher III. She expressed her appreciation to the office for providing such initiatives in conducting information campaigns and environmental awareness, most especially to the youth and the Teachers.

The first topic discussed was Biodiversity and Climate Change and it was delivered by Forest Ranger Neil Rocky A. Cabayao. He presented the impacts and effects of this on our planet. There he highlighted how threatening the melting of ice has increased and its effect on our environment.

Another topic discussed was R.A 9147 by Mr. Ser Michael Lancelot P. Gamboa, the Legal researcher. He discussed an act providing for the conservation of wildlife resources and their habitats, appropriating funds therefore, and other purposes. He also emphasized the importance of conservation and the penalties that may be acquired if a violation is present.

The last topic discussed was presented by Forester II Jiely Rose Galindez. There she presented the R.A 9003 or the solid waste management program. She presented the impacts of Improper Solid Waste Disposal and the effects of this on our environment most especially on waste disposal. There she highlighted how hazardous wastes have increased in the collected waste due to the too much use of plastics on our planet, also, the risks and threats that improper waste disposal can give to the people/community.
