

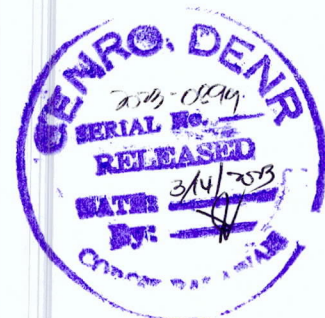

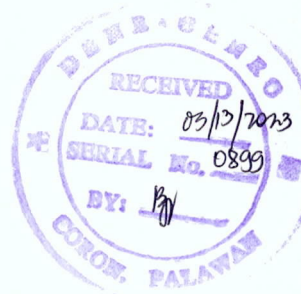

IMPROVED FPMS AND FIRE PRONE AREA OF CENRO CORON,  
PALAWAN**

Please be informed that For. Jeffrey Castro, the designated Planning Officer of this office conducted project monitoring and inspection on all implemented projects, activities including initiatives within CENRO Coron area of jurisdiction.

On March 2, 2023, monitoring of constructed and improved Forest Product Monitoring Station (FPMS) within Coron Sector (Dipulao FPMS and San Nicolas FPMS) were first inspected and found out to be conducive and appropriate as a Monitoring Station.

On March 3, 2023, with the assistance of the Monitoring and Enforcement Section chief and its staff, we proceeded to Busuanga, Palawan to check/monitor the established Banaba Forest Product Monitoring Station as well as the construction of Salvacion FPMS both in the said municipality.

The construction of Salvacion FPMS still needs some assistance and effort from the Enforcement Section in terms of logistics and materials to finish such station to cater the Busuanga Sector stakeholders like what they did at the established FPMS located at So. Banaba, Old Busuanga, Busuanga, Palawan where residents and nearby barangays served.

Later in the afternoon, the team proceeded to Brgy New Quezon, Busuanga, Palawan to inspect the identified Fire Prone Area submitted which is intended for the establishment of Fireline for the protection of graduated National Greening Program site in the area. Upon inspection, the undersigned found out that the 75-hectare plantation has a very low survival rate that only few cashew tree were survived. The inspecting officer, recommends to find another site with high survival rate to protect the plantation from the fire during the approaching dry season.

On March 4, 2023, we pushed on searching other areas or graduated NGP plantations with abundant planted tress with high survival rate and we end up at Sitio Bantad NGP plantation

in San Nicolas, Coron, Palawan and we found out that the plantation had a very high survival rate of 89% based on latest validation conducted in the area.

Listed hereunder are the recommendations of the designated Planning Officer on his inspection/monitoring conducted, to wit:

1. Forest Product Monitoring Station

- Pursue the construction of the Salvacion FPMS and continue the improvements of the other stations to serve the people and enforce the Environmental laws, rules and regulation to protect and conserve our environment.

2. Fire Prone Area

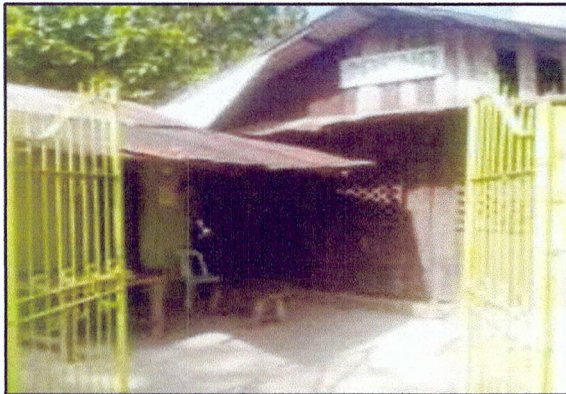
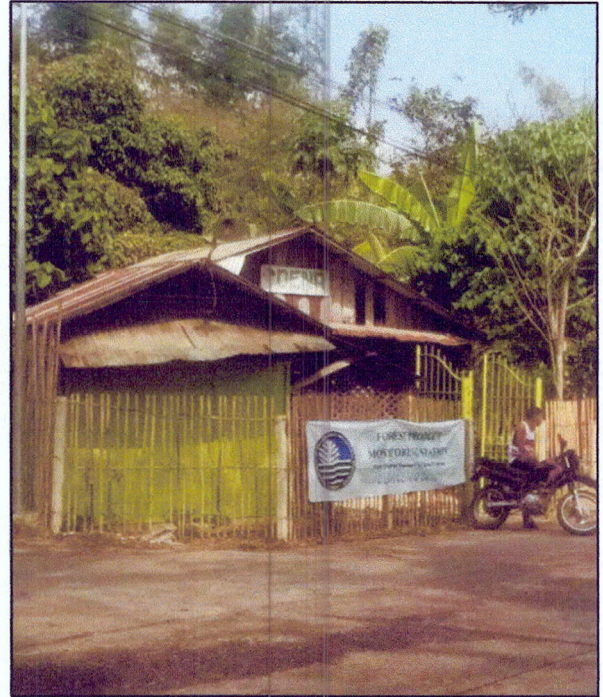
- To replace and/or resubmit an area such as graduated NGP site that really needs to protect and with high risk of fire occurrence to serve the purpose of establishing a fireline for the betterment of the area.
- To find immediately a group of people or contractor to do the activity and submit its contract to accomplish the target.
