Respectfully submitted is the report regarding the conduct of activities on the naming of watershed in Brgy. Udalo, Abra de Ilog, Occidental Mindoro. This is in compliance with our target under the 003: Adaptive Capacities of Human Communities and Natural Systems Improved Environment and Natural Resources Resiliency Program Natural Resources Assessment with performance indicator "Watershed boundaries validated/updated and named based on ridge—to-reef validated boundary".

For CY 2023, DENR's target to name all watersheds and their respective sub-watersheds through the ridge-to-reef approach, the DENR Memorandum Circular No. 2022-04, "Guidelines for the Naming of Watershed in the Philippines" served as its reference.

The Udalo River Watershed is situated in Brgy. Udalo, Abra de Ilog, covering 4,264.84

Email: mimaroparegion@denr.gov.ph Website: mimaropa denr.gov.ph hectares of alienable and disposable (A&D) lands and forestland in the municipality of Abra de IIog. Previously the area covered 4,162.33 hectares but because of the flood, landslides, and erosion of riverbanks caused by weather-related phenomena, there were changes in the river course.

Ground validation was undertaken in coordination with the local communities and the concerned municipal local government, as well as the barangay officials. Key informant interviews and consultative meetings were conducted to enable broader participation and ensure reliability of information with respect to the history of the subject watershed to wit:

Consultative Meetings

These activities were done in coordination with the officials of the Local Government Unit of Abra de Ilog and Brgy. Udalo. LGU officials were duly informed of the activities conducted leading to the naming of Udalo River Watershed, which include among others, the ground validation and the approval from the Barangay Officials through the issuance of a resolution.

Issuance of Barangay Resolution

To facilitate the approval of the naming of Udalo River Watershed through the issuance of a Barangay Resolution, personnel of this Office attended Regular Session of the Sangguniang Barangay of Udalo then presented DENR Memorandum Circular 2022-04 and the biophysical profile of Udalo River to have a better understanding of the context, principles, and policies related to the naming of watershed.

On September 27, 2023 in a session duly convened by its members, the Sangguniang Barangay approved **Barangay Resolution No. 2023-13** adopting the name of **Udalo River Watershed** as the official name of the watershed. On October 16, 2023 the result of ground delineation survey was also presented to the members of the Sangguniang Bayan Members of Abra de Ilog.

Recommendations:

In view of the foregoing, this Office respectfully recommends that the name **Udalo River Watershed** be officially adopted and be entered in the Official Registry of Watersheds of the Philippines.

c) Ms. Widmann notified the body that an IP community led by Charmaine Batac and Joel Limsa sent a communication to KFI inviting the RIWS-PAMB to attend a hearing at their Municipal Tribal Hall on August 14, 2023. Based on verbal communication with the IP group, they insisted that penalties be imposed to the PAMB for violating the IPs customary laws and failing to secure Free, Prior Informed Consent (FPIC) for its activities in the island. The RIWS-PAMB concurred that upon receipt of the letter, the same shall be endorsed to the DENR Regional Office for the instruction of the RED/PAMB Chairperson. The RIWS-PAMO shall also coordinate with the PENRO Palawan for immediate appropriate response on the said invitation.

Respectfully submitted is the Memorandum dated August 25, 2023 of OIC, PENRO Occidental Mindoro regarding the above subject in compliance with the target under OO1: Natural Resources Conservation and Development Program: Protected Areas, Caves and Wetlands Development and Management Sub-program: I. Proclaimed and Legislated PAs: 4. PA Habitat Protection; A. Implementation of Biodiversity Monitoring System (BMS) within Mount Calavite Wildlife Sanctuary (MCWS) in Paluan, Occidental Mindoro.

BMS was conducted using four (4) main methods: Focus Group Discussion (FGD), Field Diary, Photo Documentation and Transect Walk.

1. FOCUS GROUP DISCUSSION (FGD)

FGD was conducted on August 02, 2023 in Harrison, Paluan, Occidental Mindoro. It was participated by the Community Monitoring Group (CMG) from Sitios Ulasan and Hinugasan. During the CMG meeting, the main issue discussed was the concern of the CMG members of So. Ulasan regarding their resources found within their territory, specifically timber being utilized by other members of Iraya communities.

Below are the proposed management interventions regarding the issue for the 2nd semester CY 2023 in MCWS.

2. FIELD DIARY

Below are the priority monitoring species recorded using Field Diary in Mount Calavite Wildlife Sanctuary (MCWS) for the second semester CY 2023.

Among the five (5) priority monitoring species, the Long tailed-Macaque (*Macaca fascicularis philippensis*) has the highest number of individuals recorded while Mindoro Warty Pig (*Sus oliveri*) has the lowest number of individuals recorded throughout the 2nd semester CY 2023. However, Mindoro Imperial Pigeon was not observed for this year, this may signal potential changes in their status within the sanctuary. Continuous monitoring of the priority species is undertaken within the protected area.

3. TRANSECT WALK

A total of sixty-nine (69) individuals composed of eleven (11) faunal species were observed during the transect walk in the established 2-km transect line. Out of these sixty-nine (69) faunal species, three (3) are threatened species, the Mindoro Tarictic Hornbill (*Penelopides mindorensis*), Mindoro racket-tail (*Prioniturus mindorensis*) and Mindoro hawk-owl (*Ninox mindorensis*).

The table below shows the list of priority species observed in the two established sites.

P2023-117821 The result of Transect Walk for the 2nd semester is notably lower with sixty nine (69) individuals and eleven (11) species compared to ninety four (94) individuals composed of fifteen (15) species observed and recorded during the 2nd semester of the previous year. The decrease in number of individuals recorded may be attributed to the weather condition during the time of recording. Transect Walk was conducted after a typhoon with a weather condition of cloudy and foggy with minimal rainfall. While this year's Transect Walk records a lower number of priority species and individuals, the documentation of three out of five priority species remains significant. The presence of the species **Mindoro Tarictic Hornbill** (*Penelopides mindorensis*), Red Jungle Fowl (*Gallus gallus*), and Long Tailed Macaque (*Macaca fascicularis philippensis*) indicates their continuous existence in the protected area.

4. PHOTO DOCUMENTATION

There was no significant change observed during the monitoring conducted for the 2nd Semester CY 2023.

Herewith is the 3rd quarter CY 2023 report on the analysis of data obtained from science-based real-time watershed monitoring instruments installed in the Mag-Asawang Tubig River Watershed and Bongabong River Watershed. The report highlights that the Bongabong River Watershed received more rainfall (954.6 mm) than the Mag-Asawang Tubig River Watershed (930.8 mm) during this period. Additionally, it noted a water table drop of 4.3 meters in the mid part of the Mag-Asawang Tubig River Watershed, which was subsequently recharged by typhoons Egay and Goring. Flooding events recorded by the Abaton-AWLS are also mentioned in the report, with the most significant flooding occurring during Typhoon Egay.

In summary, the report provides essential data and insights of the rainfall patterns, water table fluctuations, and flooding events in the above-mentioned river watersheds. It highlights the impact of typhoons on recharging aquifers and a notable challenge in maintaining monitoring instruments due to the absence of a Technical Expert within the Department.
