EXECUTIVE ORDER NO. 682

DESIGNATING CALAPAN CITY AS THE REGIONAL CENTER OF REGION IV-B OTHERWISE REFERRED TO AS THE MIMAROPA REGION

WHEREAS, it is the policy of the Government to promote regional development in order to spur and accelerate economic growth in the countryside and thereby, attain sustainable national development;

WHEREAS, the designation and development of Regional Center in every region does not only foster efficient and effective delivery of government services, but likewise facilitate the establishment of new center of government thereat that can induce economic activities and jumpstart the growth and development in the countryside;

WHEREAS, there is an urgent need to designate a Regional Center for Region IV-B otherwise known as the MIMAROPA Region, to foster better coordination and promote efficiency in the delivery of the services by the Regional Offices of the area, and allow the development of a new government center in the region.

WHEREAS, the Regional Development Council IV-B, in its Resolution dated 30 August 2007, has favorably endorsed the designation of Calapan City as the Regional Center of the MIMAROPA Region;

WHEREAS, the President, under Administrative Code of 1987 and other existing laws, has the authority to designate the Regional Center for every region under her continuing authority to reorganize the administrative structure of the Executive Branch;

NOW, THEREFORE, I, GLORIA MACAPAGAL-ARROYO, President of the Republic of the Philippines, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. Designation of the Regional Center of Region IV-B. The City Of Calapan in Mindoro Oriental is hereby designated as the mandated Regional Center of the Regional IV B. In line with this, the Provincial Government of Mindoro Oriental and City Government of Calapan shall jointly identify, develop, maintain and administer the specific and appropriate site for said Regional Center within the boundaries of Calapan City.

- **SECTION 2.** Funding. The funding for the development, maintenance and administration of the Regional Center and site may be drawn from internally generated funds of the concerned LGUs, national government, and from other funding sources which may include private and business sector through schemes allowed under existing laws.
- SECTION 3. Catalyst for New Government Center. The development and operation of said Regional Center shall be directed toward evolving it into a new center of government that will induce economic activities and spur development in the Region. For this purpose, the NEDA Regional Office IV-B, in coordination with the Office of the Presidential Adviser for New Government Centers, the pertinent Local Government Units, the concerned government agencies and instrumentalities, and private sector, shall formulate an overall program and strategy to achieve this objective. Such program and strategy shall be submitted to the Regional Development Council IV-B for its adoption and inclusion in the regional investment priority plan of the MIMAROPA Region.
- SECTION 4. Transfer of Regional Offices in the Regional Center. All the Regional Offices in Region IV-B shall immediately relocate in the above mandated Regional Center, starting with the establishment of their satellite offices in the area within six (6) months from the effectivity of this Order, and their full transfer within eighteen (18) months thereafter. For this purpose, the Regional Offices shall adopt and implement the respective relocation plan which should incorporate measures to address possible concerns of employees affected by the transfer.
- **SECTION 5.** Roles of the Government Agencies. All heads of Departments, Agencies and Bureaus, including Government-Owned-and-Controlled-Corporations and Government Financial Institutions, are hereby directed to provide support to the above transfer of the Regional Offices, and to the development of the Regional Center in Calapan City as well as to its promotion as the new center of government in MIMAROPA Region.
- **SECTION 6.** Reportorial Requirement. The Regional Development Council IV-B, through the NEDA Regional IV-B, shall submit regular status report to the Office of the President, copy furnished the Office of the Presidential Adviser for New Government Centers and the Presidential Management Office, on the compliance by the concerned Regional Offices and their respective Departments and Head Offices with this Order, and the progress of the Implementation of the above program and strategy for the new center of government.
- **SECTION 7.** Repealing Clause. All Orders and issuances or any part thereof, which are deemed inconsistent with this Order, are hereby repealed or modified accordingly.
- SECTION 8. Effectivity. This Order shall take effect immediately.



ORDER

Records show that on November 08, 2013, a *Contract Agreement* - Cadastral Survey Project Under Category C in the Barangay of Cabayugan, Puerto Princesa, Palawan, in the amount of One Million One Hundred Ninety Thousand Seven Hundred Eighty One Pesos (PHP1,190,781.00) was executed by the DENR Regional Office IV-B MIMAROPA thru its then Regional Executive Director Edgardo O. Galeon, and Engr. Nelson M. Gabayan of N.M. Gabayan Surveying.

On November 08, 2013, a Notice to Proceed was issued to Engr. Gabayan. The 15% Mobilization Fee was paid to Engr. Gabayan on May 21, 2014.

On June 25, 2015, a cadastral meeting was held wherein then Assistant Regional Director (ARD) Vicente B. Tuddao, Jr. informed Engr. Gabayan that the submission of Survey Returns of the said Project must be summitted on July 03, 2015.

However, it appears that Engr. Gabayan failed to submit the Survey Returns because a letter dated September 15, 2015 was sent informing him that the contract will be rescinded due to the delay of submission of the required and acceptable outputs, as recommended by the Chief, Surveys Division Engr. Roman G. Legaspi to then RD Oscar C. Dominguez.

On November 04, 2015, Engr. Gabayan stated in his letter that "the final preparation of the plan was still pending waiting for the cancellation of the previous survey under Cad. 800-D, Puerto Princesa Cadastre" and that on "June 25, 2015, the undersigned [Engr. Gabayan] attended the contractors meeting held at City State Tower Hotel. During the meeting the OIC-Chief, Surveys and Mapping Division commit(sic) that the undersigned [Engr. Gabayan] shall be furnish(sic) of the cancellation of Cabayugan Cadastre."

On December 23, 2015, then ARD Tuddao sent a letter to Engr. Gabayan informing him that the Contract for Barangay Cabayugan was subject for cancellation and the 15% mobilization fund must be returned to the government:

"Please be informed that as early as October 22, 2013, as agreed and committed during the Cadastral Survey Contractors Meeting with acceptance and promise of commitment, all Cadastral Survey Projects shall be submitted at the end of 2014 and the date of approval of lot survey is on January 20, 2015, but as of this date, no GPS data and lot survey were submitted for verification and approval and you are Three Hundred Thirty Five (335) calendar days overdue from the completion of your project. xxx

Moreover, in the conduct of lot survey and as per contract, your duty is to execute the survey based on the Terms of Reference (TOR) as stated on the Manual on Land Survey and Procedures (DMC-2010-13).

Section 68, Rule XXII of the Revised Implementing Rules and Regulations of Republic Act 9184 states: xxx

Therefore, your contract was subject for cancellation and return to the Government the 15% mobilization fund amounting to One Hundred Twenty Three Thousand Six Hundred Fifty Eight Hundred and Four Centavos (Php. 123,658.04)"

Page 1 of 3

The following are stipulated in the Contract Agreement:

2. It is an essential condition of this contract that in all cases where the obligation falls due, demand is not necessary. Any payment or failure of THE FIRST PARTY¹ to enforce any of the terms and conditions of this contract shall not be construed as a waiver or renunciation on the part of THE FIRST PARTY of the right and remedy to enforce the said terms and conditions;

xxx

- 5.3. Ten percent (10%) of all partial payments shall be retained to take care of the contingencies. Such amount shall be paid to the contractor not earlier than six (6) months after approval and final acceptance of the project and upon certification from the RTD for Lands, through the recommendation of the Chief, Surveys Division, that there are no valid complaints on record filed against the execution of the project.
- 5.4 The RED, upon recommendation of the RTD for Lands shall have the right to withhold any payments due until the contractor has submitted a sworn statement and/or other proofs satisfactory to the RED, certifying that, at the time payment is demanded, he has no pending obligations and materials used in the project.

xxx

6.2 The aforementioned penalties shall be without prejudice to the filing by the RED of any criminal, civil and administrative case with the GEPI and with the Board Examiners for G.E. for the cancellation of license and the imposition of appropriate disciplinary action against the erring G.E.

Clearly, under Item No. 5.4, the Regional Executive Director (RED), upon the recommendation of the RTD for Lands shall have the right to withhold any payments due until the contractor has submitted a sworn statement and/or other proofs satisfactory to the RED, certifying that, at the time payment is demanded, he has no pending obligations and materials used in the project.

Instead of submitting a sworn statement and/or other proofs, Engr. Gabayan submitted a letter dated March 05, 2018, wherein he lamented that it is "unfair to award a project and of course to the contractor when there is still issues which is(sic) unresolved."

As a contractor of this office, Engr. Gabayan's only duty is to what was stipulated in the contract. The complete outputs and deliverables were indicated in the Terms and Reference of the Bidding documents - to submit the complete survey returns which shall then be submitted to the Regional Technical Director for Lands (now Assistant Regional Director for Technical Services) for verification and approval.

Article 1370 of the Civil Code sets forth the first rule in the interpretation of contracts. The article reads:

Art. 1370. If the terms of a contract are clear and leave no doubt upon the intention of the contracting parties, the literal meaning of its stipulations shall control.

If the words appear to be contrary to the evident intention of the parties, the latter shall prevail over the former.

In our jurisdiction, the rule is thoroughly discussed in Bautista v. Court of Appeals:

The rule is that where the language of a contract is plain and unambiguous, its meaning should be determined without reference to extrinsic facts or aids. The intention of the parties must be gathered from that language, and from that language alone. Stated differently, where the language of a written contract is clear and unambiguous, the contract must be taken to mean



that which, on its face, it purports to mean, unless some good reason can be assigned to show that the words should be understood in a different sense. Courts cannot make for the parties better or more equitable agreements than they themselves have been satisfied to make, or rewrite contracts because they operate harshly or inequitably as to one of the parties, or alter them for the benefit of one party and to the detriment of the other, or by construction, relieve one of the parties from the terms which he voluntarily consented to, or impose on him those which he did not.

Here, Item Nos. 5.4 and 6.2 of the Contract Agreement are clear. Thus, it leaves no room for equivocation or interpretation as to the exact intention of the parties.

WHEREFORE, premises considered, the following are hereby ordered:

- 1. The Contract Agreement dated November 08, 2013 is hereby CANCELLED.
- 2. Engr. Nelson M. Gabayan shall **RETURN** to the Government the 15% mobilization fund amounting to One Hundred Twenty Three Thousand Six Hundred Fifty Eight Pesos and Four Centavos (PHP123,658.04).
- 3. The Chief, Surveys and Mapping Division is **DIRECTED** to submit an updated Completed Staff Work with categorical recommendations regarding the *Contract Agreement* in preparation for the filing of Complaints to the Geodetic Engineers of the Philippines, Inc. (GEPI), and the Board Examiners for Geodetic Engineers against Engr. Nelson M. Gabayan.

3) Focus Group Discussion (FGD)

It was observed that the use of marine and terrestrial resources declined due to bad weather condition. Continuous patrolling and monitoring within the protected area were undertaken.

Proclaimed and Legislated PAs: 4. PA Habitat Protection; A. Implementation of Biodiversity Monitoring System (BMS) within Malampaya Sound Protected Landscape and Seascape (MSPLS) in Palawan.

BMS was conducted using five (5) methods: Field Diary, Transect Swim, Transect Walk, Photo Documentation, and Focus Group Discussion.

1). Field Diary

During the conduct of regular patrolling in Barangays Abongan, Bato, Minapla, Alcalain, Tumbod, Libertad, Liminangcong, Banbanan, Alimanguan, New Guinlo, Old Guinlo, Pancol, and Poblacion all within Taytay, Palawan, several important faunal species were recorded such as Palawan Hornbill (*Anthracoceros marchei*), Blue-naped Parrot (*Tanygnathus lucionensis*), Grey Imperial Pigeon (*Ducula pickeringii*), Hooded Pitta (*Pitta sordida*), Blue-headed racket-tail (*Prioniturus platenae*), Palawan Shama (*Copsychus niger*) and Philippine Duck (*Anas luzonica*).

2) Photo Documentation

During the conduct of the Transect Walk, photos were taken in three (3) different sites: Old and New Watershed Areas of Brgy. New Guinlo and Watershed Area of Brgy. Old Guinlo. For the 2nd Semester, no significant change was observed.

3) Transect Walk

The activity was conducted within the five (5) established permanent monitoring sites in New and Old Watershed, Brgy. New Guinlo, Sitio Malatek-latek, Brgy. Old Guinlo, Brgys. Banbanan and Alimanguan, San Vicente, Palawan. Data shows that the Olive-winged bulbul is the most dominant species in all sites except in Old Watershed, Brgy. New Guinlo, Taytay, Palawan where the Eurasian Tree Sparrow is the most dominant.

	certification from the MENRO has allowed the cutting of the three (3) narra trees. The body decided to clarify the matter with LGU Pola before the NLNP-PAMB decides on the matter.
2. Presentation of request for PAMB resolution for the registration of tree plantations within NLNP	 APASu Fontanilla presented the documents submitted by the proponents, Geminiano and Lydia Molinar, and Sofronio Culiat, for their request for PAMB clearance for their private tree plantation within NLNP. Per inspection of the NLNP-PAMO, the proposed areas are within their respective titled land. The body noted that the planted trees include Gmelina, which
	is an exotic species – prohibited from being introduced/planted in protected areas per the ENIPAS Act of 2018. The NLNP-PAMB ExeCom initially disapproved the request for PAMB clearance of the proponents due to a violation of the ENIPAS Section 20. However, after a series of discussions and consideration, the body concurred to approve the request for clearance provided that the proponents cut the trees within a set period, and replace them with endemic species. The body further agreed to include this provision in future resolutions request with the same nature.
3. Presentation of Proposed CEPA activities under the Communication Plan of NLNP	APASu Fontanilla presented the 10-Year Communication Plan of NLNP drafted from the series of workshops
4. Proclaimed and Legislated PAs: 4. PA Habitat Protection; A. Biodiversity Monitoring System (BMS) within Naujan Lake National Park (NLNP) for the 2nd Semester CY 2023.

BMS was conducted from the months of July to September 2023 using four (4) methods: Transect Cruise, Field Diary, Focus Group Discussion and Photo Documentation.

1. TRANSECT CRUISE

Different waterbird species were recorded through the conduct of transect cruise along two (2) established areas, specifically in Bambanin dock to Malayas River (Transect Site 1) and Brgy. Malabo Lighthouse to So. Inilawan, Brgy. Urdaneta, Victoria (Transect Site 2).

A total of 1,113 individuals composed of 28 faunal species with 3 unidentified were observed during the transect cruise in the established areas. For this semester, the most abundant species observed is the Whiskered Tern (Chlidonias hybrida) with 289 individuals followed by the Yellow Bittern (Ixobrychus sinensis) with 171 individuals and Common Moorhen (Gallinula chloropus) with 107 individuals.

2. FIELD DIARY

During the conduct of Field Diary, the most abundant species observed is the Yellow Bittern (*Ixobrychus sinensis*). These Yellow Bittern were observed in almost all lakeshores areas in NLNP. Furthermore, interview from fisher folks during field monitoring of PAMO personnel revealead that the largest volume of species caught in Naujan Lake is tilapia. Tilapia is still a staple food and in-demand resource within NLNP over the period of time. Although communities are still requesting for the seeding of tilapia in NLNP, the PAMB stands firm that no tilapia fingerlings disposal shall take place since it is considered to be invasive species. A decrease in the amount of fish (Karpa, Biya, Tawis, Dalag) caught in the lake was observed for this semester. Several reasons are considered such as illegal fishing, limitations of the designated fish sanctuary and dispersal of tilapia fingerlings in the lake.

PAMBCS/IAM//11/03/23 RDATS NO. P2023-120141 The Bureau of Fisheries and Aquatic Resources (BFAR) MIMAROPA in collaboration with the PAMO has already conducted 3 dispersals of bangus along the lakeshore of Socorro, particularly in Barangays Pasi I, Pasi II, Batongdalig and Mabuhay II.

Strengthening coordination and partnership with other agencies specifically the PNP Maritime Police and Coast Guard and continuous monitoring was conducted to intensify law enforcement activities in NLNP.

3. FOCUS GROUP DISCUSSION

Focus Group Discussion was conducted on August 24 to 25, 2023 in the municipality of Naujan, Oriental Mindoro. For this semester, several issues were observed such as illegal fishing and improper waste disposal at Barangay Malabo. Below are the proposed management interventions regarding the issues for the 2nd semester CY 2023 in NLNP.

Respectfully submitted is the Memorandum dated September 6, 2023 of PENRO Palawan with the copy of the report of the Protected Area Superintendent of Tubbataha Reefs Natural Park (TRNP) regarding the above-mentioned subject. The activity is prescribed under the TRNP Protected Area Management Plan (PAMP) in accordance with the DENR Technical Bulletin 2018-05: Adopting the Management Effectiveness Tracking Tool (METT) for Assessing and Monitoring Management Effectiveness of Protected Areas.

The first assessment was conducted on August 21, 2022, and was participated by twenty-nine (29) Tubbataha Protected Area Management Board (TPAMB) members, Tubbataha Management Office (TMO) staff, and partners.

Whereas on March 2-3, 2023 a total of eight (8) new questions were answered by TMO specifically on staff security, climate change, carbon capture, ecosystem services, threat, connectivity, and conservation of key indicator species and habitats, and were included on the most recent METT.

The following are the summary results of the METT-4 as conducted by the Tubbataha Management Office, TPAMB, and partners:

1. On Threats:

- a. Transportation and service corridors. The Sulu Sea which serves as passage of international vessels may cause potential oil spill and grounding incidents that may threaten TRNP.
- b. Biological resource use and harm. Despite a decrease in illegal fishing incidents in recent years, fishing continues to pose an ongoing threat to the park.
- c. Human intrusions and disturbance. Although tourism and research are allowed in the park, impacts brought by these activities cannot be disregarded.
- d. Invasive and other problematic species and genes. Rafting organisms might transport invasive non-native/alien animals and pathogens through marine debris and migratory animals, although no research investigating this phenomenon was conducted.

- e. **Pollution entering and generated**. The untreated wastewater from dive boats entering the park and even the ranger station within the park may impact the water quality of the protected area.
- f. Geological events. Islets are prone to erosion caused by strong winds and waves due to the absence of trees that hold the soil.
- g. Climate change and severe weather. Ocean acidification caused by temperature extremes harms life forms that rely on calcium carbonate-based shells and skeleton while sea level rise causes coral drowning and coastal erosion.
- h. Governance problems. The institutional standing of TMO is undefined thus it receives no regular funding from the government and the staff is not benefiting from a secured tenure.
- 2. On Management Effectiveness, the following aspects garnered the following scores
 - a. *Planning* It scored 21/21 (100%). This includes questions on legislation, protected area size, presence and implementation of management plan and regular work plan.
 - b. Inputs It scored 13/18 (72%). The low score is attributed to the absence of Communication, Education and Public Awareness (CEPA), Tourism Officer and a regular funding. The budget remains insecure as the Park is highly reliant on outside funding to accomplish management goals, which tourism revenues cannot fully cover.
 - c. *Process* It scored 48/51 (94%). This is attributed to the close involvement of the community to enrich the protection of the area.
 - d. Outputs It scored 14/15 (93%). Through improved research capacity and collaboration with external researchers and agencies, threats to the main value of the park are being addressed.
 - e. Outcomes It scored 7/9 (77%) the low score is due to the deteriorating condition of Bird Islet and coral reefs. Several management interventions are being implemented to address this issue.

The TRNP got an overall score of 103 points out of 114, equivalent to 90%.
