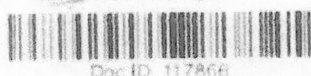

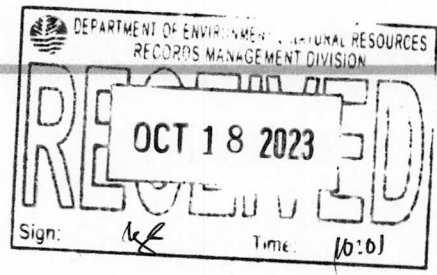

This pertains to the data population of the Web-based River Basin Integrated Information Management System (RBIIMS).

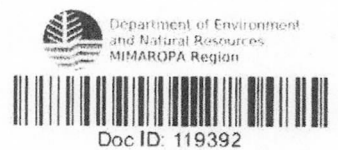

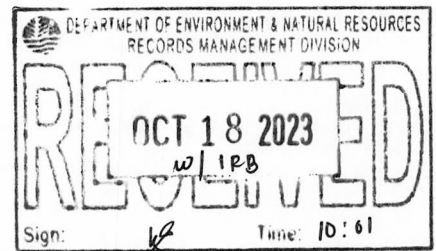

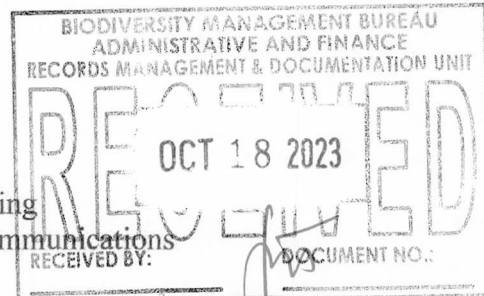

Respectfully submitted is the Memorandum dated August 31, 2023 of the OIC, PENRO Oriental Mindoro regarding the above-mentioned subject.

The attached Completed Staff Work (CSW) for the MT Princess Empress oil spill incident in Oriental Mindoro presented the following aspects, to wit:

1. Situational overview of the incident;
2. Effects and impacts of the oil spill on the province of Oriental Mindoro;
3. Responses/actions taken by this Office, along with our Field Offices in Oriental Mindoro, to mitigate the impacts of the oil spill incident, i.e., meetings attended/participated and coordination made with other NGAs, LGUs, and other concerned entities; convergence with the Department of Social Welfare and Development (DSWD) regarding Cash-for-Work Program for the affected and displaced fisherfolks; monitoring of water and air quality (particularly on oil and grease parameter); assistance in the clean-up operations (hauling of collected oil wastes and contaminated debris); Information, Education and Communication (IEC) campaigns, among others;
4. Donations received by this Office for oil spill response;
5. Termination of the shoreline clean-up operations in affected areas;
6. Remaining issues and concerns; and
7. Ways forward

Relative thereto, hereunder are the recommended ways forward for the mitigation of impacts caused by the said incident for your consideration, to wit:

1. Conduct of comprehensive assessment on the damages to the coastal and marine ecosystems in order to determine the actual extent of the ecological impact and value ecosystems services lost since the onset of the said incident;
2. Restoration/Rehabilitation of the affected areas through mangrove nursery establishment for enrichment planting, conduct of clean-up drives, and IEC

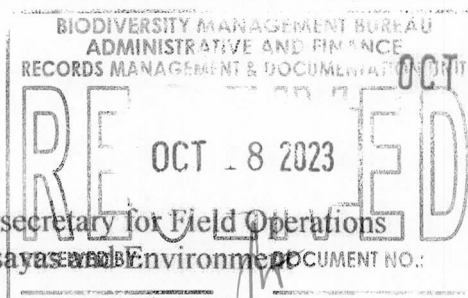

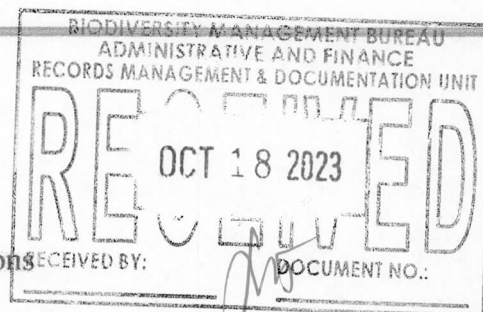
Please be informed that the En Banc Meeting was presided over by Mr. Zanie Seracarpio, representative of Congressman Edgardo L. Salvame, 1st District of Palawan, and attended by twenty-three (23) out of the thirty five (35) PAMB members.

Of the five (5) PAMB Resolutions passed in the meeting, three (3) were approved/affirmed while one (1) was deferred/returned for clarification with the PAMO regarding certain issues and concerns related to the Comprehensive Development and Management Plan (CDMP) on the proposed project of LGU El Nido on the construction of Bacuit Bay Islands public toilet.

On the other hand, one (1) resolution was disapproved as it involved a request to retain certain PAMB members who are not mentioned in Section 11 (PAMB composition), RA 7586, as amended. The request was based on the Internal Rules and Regulations (IRR) passed by the ENTMRPA PAMB on September 2006.

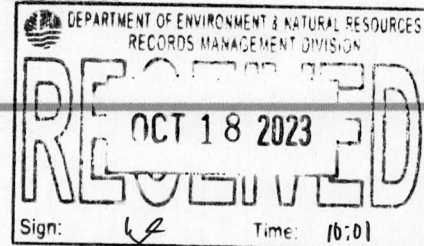

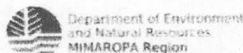
