Respectfully submitted is the Memorandum dated July 14, 2023 of OIC, PENRO Romblon regarding the above subject in compliance with the target under OO1: Natural Resources Conservation and Development Program: Protected Areas, Caves and Wetlands Development and Management Sub-program: I. Proclaimed and Legislated PAs: 4. PA Habitat Protection; A. Biodiversity Monitoring System (BMS) within CALSANAG Watershed Forest Reserve (CWFR) in Romblon for the 2nd Semester of CY 2023.

BMS was conducted using four (4) methods: Focus Group Discussion, Transect Walk, Field Diary and Photo Documentation.

1. FOCUS GROUP DISCUSSION (FGD)

FGD was conducted on July 12, 2023 at Sitio Upper Pader, Balogo, Calatrava, Romblon. It was participated by nineteen (19) members of the Community Monitoring Group (CMG). The CMG members actively participated in providing information on the trends of biodiversity and resource uses within the protected area. It was reported that the most used resources are "baliw" leaves, timbers, freshwater fishes and shrimps. For this semester, no record of illegal hunting was reported.

2. TRANSECT WALK

Table 1 below shows the priority species monitored within the established 2km transect line in Sitio Upper Pader, Brgy. Balogo, Calatrava, Romblon.

The project for the maintenance of CWFR facility was awarded to contractor Sim Construction, Trading and Services with a total amount of Php 149, 275.48 and was finished from June 02, 2023 to June 13, 2023, which is ahead of the contract period of 32 days. The item of works include: 1) installation and fabrication of window and door grills; and 2) replacement of main door and ceiling.

The facility serves as an information/reception area for inbound visitors, PA monitoring office, and a display area for locally-made products in support of community-based ecotourism development in CWFR.



MUNICIPALITIES OF ROMBLON (DATS NO. 1-2023-115507)

This is to acknowledge receipt of your Memorandum dated August 07, 2023 regarding the submitted Completed Staff Work on the conduct of verification/investigation on the reported death of marine turtles in various municipalities of Romblon.

Accordingly, the cause of death of the twenty-three (23) unidentified marine turtles was illegal activity (i.e. poaching) found in various municipalities of Romblon, however, verification of the said report should be done and should be properly coordinated with the appropriate enforcement agency.

Relative to this, in responding to marine turtle incidents, it must be decided what type of response is needed based on given situation. ¹A stranding is a situation wherein marine turtles are washed ashore dead, or alive but weak, or seen floating at sea but are already dead or are still alive but weak would require a response. To correctly select the course of action, it is necessary to adequately gather as much information from the source as possible in order to verify the report and fill in any information gaps. If a marine turtle is dead, data and tissue collection should be maximized. To determine the cause of death, the following actions should be taken:

- 1) Interview knowledgeable respondents on the incidents;
- 2) Assessment of the environment for possible cause (e.g. pollution, fishing activities in the area, weather condition, etc.) and;
- 3) Necropsy and tissue sampling.

Whenever possible, a necropsy report must be immediately done and must be performed by a DENR-trained licensed veterinarian or a veterinary assisted biologist knowledgeable in marine turtles and their biology. Although dead marine turtles can be necropsied, the degree of decomposition will limit the amount of diagnostic information that can be gained.

The CDS of CENRO Roxas conducted flying fox monitoring and survey in Barangay Caramay, Roxas, Palawan on July 13-14, 2023. A total of four hundred twenty five (425) bats were counted at Rheinart Island located between Barangays Caramay and Nicanor Zabala, Roxas, Palawan. The area was unpopulated but surrounded by coconuts, *Sonneratia alba* and *Rhizophora appiculata* mangrove species.

On July 24-26, 2023, the CDS staff of CENRO Quezon conducted survey to assess the population and monitor the flying fox habitat at So. Manduros, Barangay Panalingaan, Rizal, Palawan. The assessment and monitoring activities were carried out using a combination of observational counting and interviews with local residents. A total of four thousand one hundred ten (4,110) bats were counted at So. Manduros, Brgy. Panalingaan, Rizal.

In response to the letter dated August 16, 2023 of Hon. Leody "Odie" F. Tarriela re Request for Funding for Additional Forest Rangers to Guard Critically Endangered Tamaraws in Occidental Mindoro, this Office respectfully submits a Work and Financial Plan for CY 2024 for a proposed additional fund amounting to P20,000,000.00. Please be informed that the budget allocated by this Office for CY 2024 for tamaraw conservation amounts to P4,788,000.00 covering the following regular activities of the Tamaraw Conservation Program (TCP):

- 1. Hiring of at least 25 TCP staff considering that only one (1) permanent personnel, designated as Coordinator, is assigned to the program
- 2. Annual population monitoring of the tamaraw core habitat within Mts. Iglit-Baco Natural Park (MIBNP)
- 3. Communication, Education and Public Awareness (CEPA) activities such as production of materials, conduct of *dalaw turo*, and celebration of the Tamaraw Month
- 4. Maintenance of TCP compound and 3 Ranger Stations
- Management of Tamaraw Genepool Farm which is also designated as Wildlife Rescue Center (WRC) for the province of Occidental Mindoro

The said amount was taken from the P5,265,000.00 budget ceiling for the province of Occidental Mindoro under the CY 2024 National Expenditure Program (NEP) – Wildlife Resources Conservation Sub-Program. The remaining amount of P477,000.00 is allocated for marine turtle monitoring of nesting sites, rescue and response operations of stranding incidences, Asian Waterbird Census (AWC), survey on Philippine teak (Tectona philippinensis), and Program and Management Supervision (PMS) fund of the PENRO Occidental Mindoro.

In order to address the concerns (i.e. constant forest degradation and undermanned and underpaid TCP rangers) raised in the letter of Hon. Congressman Tarriela, this Office has prepared a Budget Proposal matrix and Work and Financial Plan detailing the proposed activities for CY 2024 intended to improve the conservation status of the critically endangered tamaraw by addressing the threats to its population.

Republic Act No. 9147, Section 22 has provided the following criteria in the determination of a species' conservation status:

"a. present or threatened destruction, modification or curtailment of its habitat or range;

b. over-utilization for commercial, recreational, scientific or educational





Relative hereto, a total of 403,529 seedlings are being maintained under the jurisdiction of PENRO Oriental Mindoro, PENRO Occidental Mindoro and PENRO Palawan under the 3rd year maintenance and protection activities.

As to the financial status of the project, a total of Php 1,562,100.00 of contracted amount was disbursed by PENROs Occidental Mindoro, Oriental Mindoro and Palawan.

Respectfully submitted are the Memoranda dated June 26, 2023 and August 7, 2023 of PENRO Palawan submitting the reports of CENRO Brooke's Point and its enclosures on their request for the Municipality of Bataraza to be excluded from the list of illegal logging hotspot area.

Please be informed that on January 31, 2023, this Office submitted the documents to substantiate the said request, which focused on the series of activities conducted by the concerned CENRO in coordination with different Local Government Units and other stakeholders, particularly the issuance of Municipal Resolution No. 74, Series of 2022, by the Municipality of Bataraza.

To date, CENRO Brooke's Point and the LGUs are focused on neutralizing illegal logging activities in Bataraza. However, various concerns were identified, notably the lack of hauling vehicles and the failure of the barangay officials to enforce protection and conservation of the environment as devolved functions pursuant to the Local Government Code and Executive Order No. 138, s. 2021.

In this regard, may we respectfully inquire for an update on the status of the request of CENRO Brooke's Point and the Municipality of Bataraza. May we also seek for the provision of much needed logistics to sustain the fight against illegal logging and other unlawful environmental activities.
