Respectfully submitted are the Compliance Monitoring Reports including the prescribed forms covering the 3rd Quarter of CY 2023 on the issued Wildlife Farm Permit (WFP), Wildlife Collector's Permit (WCP) for breeding, and Certificate of Wildlife Registration in the provinces of Marinduque, Oriental and Occidental Mindoro.

Based on the report, there are three (3) WFP/WCP holders under the jurisdiction of PENRO Oriental Mindoro: one (1) monkey farm and two (2) butterfly farms. All are found compliant with the terms and conditions stipulated in the approved permit. However, it was observed that the butterfly farms were affected by the recent pandemic since the market demand declined significantly.

In the province of Marinduque, there are fourteen (14) WFP/WCP holders (butterfly farms) and all are also found compliant with the terms and conditions stipulated in the approved permit. In addition, the Monitoring Team disclosed that the previous observations which needed to be addressed by the proponents were already complied. The facilities are fully operational, well-maintained, and with regular transactions supported by the issuance of Local Transport Permits (LTP).

As for the issued Certificate of Wildlife Registration (CWR) in the province of Marinduque, the previous observations of the Monitoring Team such as non-compliance in the submission of monthly breeding reports and labeling of names of wildlife species for proper identification were already acted upon by the proponent. As for the CWR holder in Occidental Mindoro, the proponent was found non-compliant in the submission of monthly breeding reports. A Memorandum of instruction with an even date was issued to PENRO Occidental Mindoro to implement the recommendation of the Monitoring Team (copy attached as Annex A)

This Office recognized the efforts of the permit holders in maintaining their farm facilities despite the challenges brought by the recent pandemic and assured that the permit holders will receive technical support, as needed, to maintain their compliance and good performance as well.

Respectfully submitted is the Memorandum dated 31 July 2023 of PENRO Palawan together with the copy of the pertinent documents relative to the above subject. This is a part of the accomplishment for the CY 2023 target activity under OO1: Natural Resources and Development Program: Protected Area Management and Development Sub-program: II. For Proclaimed and Legislated PAs: 5. PAMB Operationalization; Capacity Building of Ursula Island Game Refuge and Bird Sanctuary (UIGRBS).

The Protected Area Management Office (PAMO) of UIGRBS organized a training session on July 4-8, 2023 at Riverside Inn, Bataraza, Palawan, whereas the actual fieldwork was done in Ursula Island Game Refuge and Bird Sanctuary. The training centered on Biodiversity Assessment and Monitoring System (BAMS) Training and Installation of Permanent Plots for Ursula Island, providing dedicated lectures on assessing and monitoring flora and fauna. The primary goal of the training is to develop and establish UIGRBS's biodiversity database in preparation for its proclamation/legislation and formulation of the Protected Area Management Plan, as well as standardizing the approach to island biodiversity monitoring. The training program was attended by a total of forty (40) individuals, composed of DENR (10), MENRO (1), RTNMC (2), CBNC (2), Brgy LGU Taratak (1), Brgy LGU Rio Tuba (2), Brgy LGU Sarong (2), PCSD (2), Haribon Palawan (2), PCG (2), Philippine Marines (2), PNP Maritime (2), PNP (2), PGENRO (2), RTNMPA (2), Tourism (1), MPDO (2), PPDO (1).

Hereunder are the topics presented by the speakers and practical fieldwork performed during the activity:

1. Flora Lectures:





The said CSC expired on 10 January 2009 and was renewed until 10 January 2034.

Review of the submitted documents showed that Mr. Anastacio Villaplaza passed away on 19 June 2014 while his spouse, Maxima Montermoso, died on 15 October 2018. Meanwhile, Mr. Anastacio's daughter, Josephine Villaplaza, is already deceased, while his two other children, Ronilo Villaplaza and Oscar Villaplaza, are already holders of CSC. Further, the parents of the CSC holder are already deceased, and his other sibling is already a holder of a CSC. Thus, Mr. Anastacio Villaplaza has no qualified next-of-kin who may inherit the CSC.

Considering the above and that Mr. David Villaplaza is the actual occupant and tiller of the area, and has continuously maintained, developed, and protected the same, together with his grandfather, our Legal Division has advised that he may then be considered as other nominated person or party of the original steward provided that prior approval of DENR Secretary or his duly authorized representative is sought, pursuant to Section 1.1 of DMC No. 23, Scrics of 1993.

Henceforth, we are seeking for your approval for this Office to process the transfer of CSC of Mr. Villaplaza to his grandson, Mr. David Villaplaza.




