

This refers to the letter of DENR MIMAROPA Region dated 19 September 2023 and received on 3 October 2023 inquiring on the deputation of DENR personnel for the issuance of Certificate of Compliance on allowable easement or from exemption thereof.

Pursuant to Article 80 of the Water Code of the Philippines¹, the council may deputize any official or agency of the government to perform any of its specific functions or activities.

Currently, there is an existing NWRB Resolution No. 15-1116² deputizing DENR Regional Offices, specifically the Water Resources Utilization Section (WRUS), to perform certain functions relative to regulation of water use, to wit:

- 1. Accept/ verify water permit applications (WPAs);
- 2. Conduct continuing inventory of water users;
- 3. Identify water sources and make a water sources inventory map;
- 4. Conduct information, education and communication (IEC) campaign on the Water Code of the Philippines and its Implementing Rules and Regulations (IRR) to key stakeholders in collaboration with NWRB;
- 5. Conduct re-echo training for PENROs and CENROs and coordination meeting with other deputized agents in the area; and
- 6. Perform such other related activities as may be specifically assigned to it in accordance with the Water Code that may be agreed by the parties.

The said Resolution is presently under the process of review in order to include other functions which may be further delegated to WRUS.


Nonetheless, DENR Administrative Order No. 2021-07³ provided the guidelines on the establishment of easements. Stated therein is the provision that "the DENR Regional Offices, through their Enforcement Division shall monitor the establishment of easements in accordance with provisions of this Order. In case the area concerned is within a National Park/ Protected Areas, the Protected Area Management Board (PAMB) shall be included in the monitoring." Furthermore, "all violators shall be notified by the Region to comply with the rules. xxx The enforcement of legal easements within Protected Areas shall be guided by the provisions of Section 24 of DAO No. 2019-05." §
