

Respectfully submitted herewith is the application for Forest Landuse Agreement for Tourism (FLAgT) purposes of Sulubaai Environmental Foundation Inc. represented by its president Mr. Frederic Jean Tardieu over a forestland area located in Pangatalan Island, Barangay Dipla, Taytay, Palawan.

Review of submitted documents, assessment and validation of area applied for, and completed staff work by this office disclosed the following:

- 1. Sulubaai Environmental Foundation Inc. (SEFI)., sixty percent (60%) of the capital is owned by Filipino citizens, is duly registered under Securities and Exchange Commission and aims to plan and implement (i) projects and programs for the protection, conservation, restoration, and management of the natural resources of Palawan, including terrestrial or marine flora and fauna, and (ii) community-based initiatives to promote and develop environmentally sustainable principles and practices.
- 2. On October 23-24, 2014, a joint inspection/evaluation and assessment was conducted by the composite team from the CENRO Taytay and PENRO Palawan per Inspection Report dated November 5, 2014. During the time of inspection, the following developments were observed:
 - 2.1. Receiving Area
 - 2.2. Laborer's quarters
 - 2.3. Kitchen
 - 2.4. Small rest house made of light materials
 - 2.5. Three (3) ground water tank/reservoir
 - 2.6. Old pier made of light materials with concrete post and about 137 meters
 - 2.7. Planted ornamental plants such as bonsai plant, forest trees, fruit-bearing trees, and other plants used for landscaping
- 3. On April 11, 2017, CENRO Taytay forwarded the application thru the PENRO Palawan.
- 4. Application for FLAgT of SEFI containing an area of 6.052 hectares was forwarded to the Regional Office thru Memorandum by PENRO Felizardo Cayatoc dated April 28, 2017.
- 5. A Memorandum dated November 07, 2017 was addressed to the PENRO Palawan attention CENRO Taytay regarding the lacking requirements needed to support the subject application.

CENRO, the PENRO, and other government agencies and the fact that the applicant has completed and complied with all the requirements provided under existing policies, law, rules and regulations, we hereby respectfully recommend favorable consideration and approval of the FLAgT application.
