



This request for realignment is to make best use of the remaining fund which arises from a series of delays in the disbursement and implementation of the RLTA program, which had a total allocated fund of PHP 1,779,000 under Sub-Allotment Advice (SAA) No. 2022-04-24. The fund was released on April 1, 2022, and several subsequent delays occurred in the timeline of the project. The hiring of Community Development Assistants (CDA), Encoder, and Enumerators took place around April of the previous year, and this was followed by a cascade of RLTA in May 2022, with data gathering occurring in June 2022.

A significant challenge that further impeded progress was the failure of three bidding attempts to conduct the survey, ultimately leading to a negotiated bidding with the survey firm of Jovito Cadatal. The Notice of Award was issued on October 24, 2022, and it was accepted on October 27, 2022, with the notice to proceed being received on November 7, 2022. The survey proper was then conducted and concluded on December 5, 2022. The first survey plan was approved on March 14, 2023, and the latest approved survey was granted on October 13, 2023.

These delays in surveying and survey plan approval significantly hindered the acceptance and processing of free patent applications in the Municipality of San Agustin. 


The undersigned is respectfully requesting the utilization of the remaining fund of RLTA San Agustin amounting to PHP 227,000, re: the above cited subject matter.

The request is made due to several reasons which contributed to the delay of accomplishing the target covered by RLTA San Agustin which begun in the delay in the disbursement of the program's fund, which amounted to PHP 1,779,000 under Sub-Allotment Advice (SAA) No. 2022-04-24. This fund was released only on April 1, 2022. Subsequently, the hiring of the Community Development Assistant (CDA), Encoder, and Enumerators took place around April of the previous year. Cascading of RLTA was conducted in May 2022, followed by data gathering up to July of last year. Notably, there were three failed bidding attempts to conduct the survey, which led to a negotiated bidding with the survey firm of Jovito Cadatal. The Notice of Award was issued on October 24, 2022, and accepted on October 27, 2022, with the Notice to Proceed issued only on November 7, 2022. The survey proper was conducted and concluded on December 5, 2022. The first survey plan was approved on March 14, 2023, and the latest approved survey was granted only last October 13, 2023.

This prolonged delay in the survey and the approval of submitted survey plans has significantly hindered the acceptance and processing of free patent applications in the Municipality of San Agustin. Additionally, the absence of proper documents from the recipients, such as Deed of Sale and Extra-Judicial Partition, has contributed to the overall delay in the process. In response to these challenges, the personnel involved in the RLTA San Agustin have actively assisted our recipients in the preparation of conveyance documents and have even requested the Land Registration Authority (LRA) Certificate at no expense on their part.

Furthermore, the RLTA San Agustin project coincides with our regular targets and the current implementation of RLTA Romblon, which has further compounded the delay in achieving our goals. In light of these issues and the significant progress achieved thus far, we kindly appeal for an extension of the funding for RLTA San Agustin to complete the acceptance and processing of free patent applications in the Municipality of San Agustin.


