This pertains to your memorandum dated 07 November 2023, which outlined the proposed sites for the construction of Small Water Impounding Systems (SWIS) by PENRO Palawan in Fiscal Year (FY) 2024.

Upon careful examination of the submitted documents, it has been observed that the three proposed areas within Palawan are in close proximity to the CY 2017, 2018, and 2021 NGP Plantations. Specifically, these sites are planned for construction within So. Salpan and So. Parangue in Brgy. Aramaywan, Narra, Palawan, and Brgy. Sta. Maria, Dumaran, Palawan. It is duly noted that coordination with relevant stakeholders, as well as site reconnaissance and identification, have already been carried out.

While acknowledging that the proposed sites align with the objective to support NGP Plantation, it has come to our attention that there are no allocated funds for the construction of SWIS in Palawan for FY 2024. Consequently, we recommend including and considering the construction of SWIS at the identified three sites in Palawan in the FY 2025 Work and Financial Plan of the Region. Additionally, we would like to emphasize the primary purpose of SWIS, which is to supply water for the reforestation efforts of the DENR.

Lastly, we would like to remind the Region to adhere to the design and costing specifications outlined in FMB Technical Bulletin 13-A, titled "Supplemental Standard Cost and Design for Small Water Impounding System (Spring Development)."

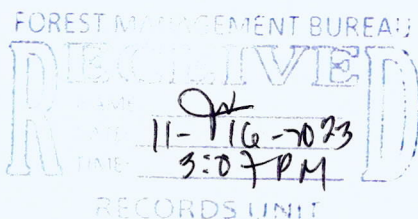
