In compliance with the letter request of Representative Jose Chaves Alvarez, 2<sup>nd</sup> district of Palawan for the establishment of *Abuyog Sweet Langka* plantation within barangays under the said congressional district, this Office respectfully submits the attached Work and Financial Plan (WFP) for possible funding under the Enhanced National Greening Program.

The total area of 1,300 hectares is being proposed to undergo site assessment/SMP activities for CY 2024 to determine site suitability insofar as site-species matching is concerned, including the validation and identification of the target partner/beneficiary of the project.

As proposed, the project aims to plant a total of 130,000 Abuyog Sweet Langka sourced from the Eastern Visayas College of Agriculture in Leyte. The total project cost for the 1<sup>st</sup> year activities shall amount to Twenty Million Five Hundred Ninety-Nine Thousand Pesos (PhP20,599,000.00) on its first year of implementation and Sixteen Million Eight Hundred Thousand Pesos (PhP16,800,000.00) both on the 2<sup>nd</sup> and 3<sup>rd</sup> Year implementation under Maintenance and Protection pursuant to DENR Administrative Order No. 2019 -03 dated January 8, 2019.
