FOREST MANAGEMENT BUREAU NAME: DATE: TIME: RECORDS UNIT	On October 10, 2023, the CENRO Roxas Monitoring and Enforcement Section (MES) personnel conducted an IEC through lecture, which was attended by the barangay officials and residents of Brgy. San Francisco, Bulalacao, Oriental Mindoro with a total of twenty-six (26) participants (12 women and 14 men). They discussed the efforts of DENR towards intensified forest protection and wildlife conservation and encouraged the participants to cooperate with the mandates of the DENR in the protection of natural resources.
	On the following day, the team also conducted an IEC through meeting, which was attended by the members of the Buhid Tribe of Mangyan community and barangay officials with a total of thirty-six (36) participants composed of nineteen (19) women and seventeen (17) men. Said meeting is to encourage the community as partner with the DENR in the conservation, protection, and sustainability of our forest resources. An open forum concluded the events, wherein common issues were raised by the participants and addressed by CENRO Roxas personnel.

CENRO Socorro	On August 11, 2023, CENRO Socorro Monitoring and
	Enforcement Section (MES) personnel conducted an IEC through lecture in Brgy. Calima, Pola, Oriental Mindoro which was attended by barangay officials and some local farmers with a total of forty-one (41) participants, composed of 18 women and 23 men, with aims to impart knowledge on ENR laws, rules, and regulations especially in coastal, marine protection and conservation. As part of the activity, IEC materials were distributed such as flyers, posters, and signboards containing important information and services offered by the CENR Office.
