3. Which shock/disturbance has affected your farming livelihood recently? In what way did it affect your farming livelihood? Has it affected your NRM sub-project/s? How? How did you cope?

4. What measures that need to done to improve the resilience of your plantations from these shocks/disturbances?

5. How can you say that forest cover/biodiversity in your village has increased? Is soil erosion a problem in your village? What contributes to it? What are your measures?

6. How has NGP contributed to your knowledge and skills or what skills have been acquired? Were you able to apply or practice these? With are what results?

7. What other skills or trainings that your organization needs that would contribute to the realization of environmental and economic objectives of NGP as well as your objectives?

8. What needs to be improved from your Organization, from among the members, leader and your officers?

9. Overall, what are the reasons that you are satisfied with the projects? Why do you think they are relevant? What is that one thing that you can be proud of or happy about in joining NGP? One that challenged you as a farmer/farmer leader?

10. What are some of the good practices here in NGP that should be sustained? Those that can still be improved
