This pertains to your follow-up letter complaint dated 20 October 2023, regarding the alleged illegal parking, loitering, violation of R.A. 7183 otherwise known as "An Act Regulating the Sale, Manufacture, and Use of Firecrackers and other Pyrotechnic Devices", grave misconduct and other untoward acts of Mr. Rodney G. Verian at Bgy. San Jose, Puerto Princesa City, Palawan.


Upon evaluation, we find it proper to formally refer this matter to your concerned barangay. Given the intricate nature of your concerns at hand and as we recognize the role of our barangays in upholding community welfare, it is best positioned to facilitate your complaints to them. Under Republic Act 7160, otherwise known as the *Local Government Code of 1991*:

SECTION. 408. Subject Matter for Amicable Settlement; Exception Thereto. - The lupon of each Barangay shall have authority to bring together the parties actually residing in the same city or municipality for amicable settlement xxx

While we deeply regret the occurrence of these incidents, we would like to affirm our unwavering commitment to upholding the principles outlined in Republic Act 6713, also known as the *Code of Conduct and Ethical Standards for Public Officials and Employees*. Our government agency places a paramount emphasis on adherence to our laws, and we consistently strive to ensure that every public servant conducts themselves with the highest level of integrity, transparency, and accountability in the fulfillment of their duties and responsibilities.

In light of this matter, we will promptly provide CENRO Rodney G. Verian with a copy of your follow-up letter, allowing him to thoroughly and appropriately address the concerns you raised.

Respectfully forwarded is the memorandum dated June 27, 2022, with enclosures from Forester Rodney G. Verian relative to the above-mentioned subject.

In relation to this, the following concerns were stated by Forester Verian in the aforementioned memorandum, to wit:

1. Mr. Elbert Calamba Reynoso is his neighbour and the owner of Villa Alexia Place located at Tambis Road, Barangay San Jose, Puerto Princesa City which accordingly has no Mayor's permit for Calendar Year 2022 (as per attached certification dated June 24, 2022 issued by Permits and Licensing Division of Office of the Mayor of Puerto Princesa City) and is currently operating.
2. Accordingly, he has repeatedly requested Mr. Reynoso regarding the proper parking of vehicles and undesirable noises of guests since their start of operations.
3. He stated that the occurred incident dated June 19, 2022 have only guests and staff of the Villa Alexia Place as witnesses and he was not present during the said incident.
4. He also cited that his house was accordingly have been stoned four (4) times dated June 20, 2022 and had sought the assistance of the Barangay LGU and Philippine National Police.
5. Further, he stated that he has filed a blotter/complaint with the Barangay Government of San Jose at around 10:22 p.m. of June 19, 2022 regarding the improper parking of vehicles owned by the guests of Villa Alexia Place and is currently preparing a case with his lawyer against Mr. Reynoso.
